What finance options are available?

Interest free credit

Interest Bearing Credit – 7.9% APR

Interest bearing credit allows you to borrow on a rate of 7.9% APR for a fixed term basis. This is available on credit over a term of 36, 60, 96 and 120 monthly payments.

Am I eligible for finance?

Who is eligible?

- Minimum age 18 years old,
- UK resident for more than 12 months,
- Own personal bank account from which a direct debit can be taken,
- Owner occupier,

- Permanent employment working minimum 16 hours per week,
- Self-employed,
- Retired person,
- On disability allowance,
- Unemployed and 'house-person' (with consent of co-habiting partner).

Who is not eligible?

- Unemployed without a spouse/ partner in full time employment,
- Temporary positions or agency workers,
- Unregistered child minders,

- Foster carers without a spouse in full time employment,
- Students (other than trainee nurses or doctors),
- Supply teacher without permanent contract to a specific school.



The application

process

The application process is simple and takes less then 10 minutes to complete and get a decision!

- Our surveyors will provide you with a fully comprehensive quotation for the installation, as well as the monthly payments dependent on the finance package you choose.
- **2.** Once you have let us know you are happy to go ahead with this, we will begin your application with Novuna Personal Finance.
- **3.** You will receive an email with a link that will take you direct to the Novuna Personal Finance website to complete your personal details. This takes around 5 minutes to complete.
- **4.** When you have completed your personal details and submitted your application Novuna Personal Finance will come back with a decision. This will either be accepted, declined or referred. We will also receive notification and will be in contact to arrange your installation if accepted.
- **5.** If your application has been accepted or referred, Novuna Personal Finance will be in contact direct to advise of payment schedules and any documents they may require.

After the installation has been completed you will be asked to sign a satisfaction note to confirm that everything is complete.
